## Legislative Analyst Report Fred Jones

### Dramatic Reforms & Controversial Implementations

As I stressed in my prior column, our History/Social Science disciplines have seen dramatic reforms in California the past couple of years, from the Ethnic Studies graduation mandate, with it's ongoing rocky rollout, and the less profiled but still historic new Personal Finance graduation requirement. Beyond these two subjects the Legislature and Governor just tweaked the Civic Seal of Engagement requirements, while efforts to advance more robust Civics have continued to stall in the Legislature. Here's a quick run-down of the latest and rather dramatic changes coming your way.

#### **Ethnic Studies**

While the Legislature and Governor passed a law (AB 101) a couple of years ago mandating a single semester Ethnic Studies (ES) course as a condition for a high school graduation, a small provision was added to that legislation that made the statewide mandate conditional on state appropriations. And that state funding effort stalled this year, meaning there is no statewide mandate beginning next school year, though districts still have the legal authority to adopt and/or maintain their own ES requirement.

The Governor's denial of funds for the mandate just means the state isn't obligated to fund these costly endeavors, nor are any districts required to implement an ES course requirement.

We covered some of the reasons why the Governor declined to allocate funding in my prior newsletter column. But the Legislature did move a bill forward in the closing days of this year's legislative session that seeks to diminish most of the controversies surrounding ES course mandates.

Authored by members of the Legislative Jewish Caucus, AB 715 sought to establish guardrails to prevent antisemitic or discriminatory content. When that effort stalled in the face of strong opposition (including the CTA), the bill was amended in the closing days of this year's legislative session to create an Office of Civil Rights to work with schools to avoid discriminatory or biased professional development, instructional materials or curriculum across all academic disciplines, not just ES. This more general, anti-discrimination approach worked and the Governor signed AB 715 into law in October.

We'll see if that also lubricates the skids that have thus far stymied the Governor and Legislature appropriating dollars to bring the statewide ES mandate to fruition next year.

#### Personal Finance

Then there's the other high school mandated course that was passed into law last year.

As I have previously highlighted, prior to AB 101's Ethnic Studies passage, the state hadn't required any additional course mandates since the 1980's ... and now they've passed not one but two in just the past three years, both in our HSS subject-matter areas. These legislative reforms have been historic and a handful for schools, teachers, parents, interest groups and students to digest.

The origins of this new Personal Finance course came on the heels of a qualified ballot initiative, which Legislators and the Governor didn't want to set the precedent for voters determining course mandates through the ballot box. So they quickly cut a deal with the initiative's backer.

Unfortunately the deal contained a cost-avoiding provision of this new mandate, allowing students the right to opt-out of the single-semester Econ course after completing the Personal Finance course. This placed our Economics course in a zero-sum game with Personal Finance, something no Econ teacher wanted (in fact, most Econ teachers consistently tell me they've included Financial Literacy elements in their Econ course for many years, so they've already embraced both).

After expressing our concern with this student opt-out, I'm pleased to report the Governor and Legislature included a small cleanup provision in the Budget bill that raises the opt-out question to the district level, rather than allow each student to make this decision on a pupil-by-pupil basis. The revised law now includes this important line (my *emphasis* added):

"Commencing with pupils graduating in the 2030-31 school year, a local education agency may exempt a pupil who completes a separate, standalone one-semester course in personal finance, that is not combined with any other course, from the requirement to complete a one semester course in economics ..."

This means districts/schools are authorized to either provide the opt-out or not. So it's incumbent on our teachers and others who support the ongoing teaching of economics to lobby their LEA leaders (Principals, Superintendents and Trustees) to save our Econ course!

#### **Civics**

Most of the recent statewide action in Civics has been focused on the State Seal of Civic Engagement. As the latest example, AB 422 (Jackson)I, which the Legislature passed and the Governor just signed, will require students to demonstrate understanding of the vital institutions of democracy, including the free press, access to public libraries, compulsory education and the federalist system.

For the second year in a row, Senator Limon's measure to drive Seal activities down to the K-8 level stalled out. Interestingly enough, the author's colleagues just elected her their new leader beginning next year, so we'll see whether the new Senate Pro Tem will have the stomach to push a third time to get such legislation over the finish line with her new-founded clout.

#### **Curricular Reforms**

Every year there are usually a half-dozen bills introduced to mandate or alter what is taught in HSS curriculum, and this year was no exception. But only one bill of significance looked like it had the momentum to make it through the legislative sausage mill, until it ran out of steam in the final weeks of session.

AB 908 (Solache) previously would've incorporated the FAIR Act (historical/ contemporary contributions of BIPOC and LGBTQ+ communities) into the SPI's Coordinated Compliance Review Manual (which currently requires districts to be compliant with the state's sexual harassment/discrimination laws). However, the bill was dramatically scaled back in July to require the CDE to ensure general compliance with state/federal anti-discrimination laws when reviewing/approving instructional materials. That last ditched effort to win passage failed, and the author moved the bill to inactive status, making it a two-year bill (meaning it could be pursued next year as part of this two-year, biennial legislative session).

As CCSS's legislative advocate, I continue to give voice to our mission to strengthen and increase HSS instruction throughout our public education system so that all pupils have the opportunity to learn their historical and geographic context, be given the tools to expand their personal and economic worth, and become actively engaged citizens in our pluralistic society.

#### California Department of Education Updates

#### State Seal of Civic Engagement Insignia Requests

The California Department of Education (CDE) is developing the 2024–25 State Seal of Civic Engagement (SSCE) statewide insignia request data spreadsheet, and anticipates posting it to the <u>SSCE web page</u> by the end of 2025, along with the updated 2025–26 insignia request form. In the meantime, resources to support local implementation of the SSCE are available from the SSCE and <u>Resources to Support Civic Engagement</u> web pages.

#### State Seal of Civic Engagement Student Data Collection

During the summer of 2025, the CDE collected data on the students who earned the SSCE in the 2024–25 school year for determining its use in the College/Career Indicator (CCI) on the Dashboard. Data was collected through an Education Data Collection System (EDCS) administered by the California Longitudinal Pupil Achievement Data System (CALPADS) Office.

This data collection is based on the State Board of Education's (SBE) request to the CDE to consider the inclusion of civic engagement in the CCI. Please note that this data is not being collected in CALPADS at this time.

#### California Serves Program

The 2022 State Budget (Assembly Bill 181, Section 71) appropriated \$5 million annually to the CDE to work with California Volunteers to establish the California Serves Program. The program supports development of effective service-learning programs through an annual grant program, with the goal of expanding access to the SSCE through high-quality service-learning. This year, the CDE anticipates awarding a fourth cohort of grantees. The Request for Applications was posted to the <u>California Serves</u> web page on September 25, 2025. Eligible applicants must submit an Intent to Apply no later than 4 p.m. on Monday, November 17, 2025. LEAs may review eligibility, submit an Intent to Apply, access the RFA, and see the full grant timeline from the California Serves web page.
